Pinewood Studios and the BFI announce a new intern programme to develop film production skills

Pinewood Studios and the BFI today announce that they will launch a new joint programme to support skills development for interns in film production. The programme will help grow and develop the next generation of film talent and provide new opportunities for people wanting to work in the film industry. The joint initiative will ensure productions financed by Pinewood and the BFI take on trainees across a number of departments, depending on the size and scale of the film. The organisations will also work with industry partners to source interns/trainees from across the UK and from a diverse range of backgrounds to learn a whole range of disciplines from craft and technical skills to production services.

Pinewood Studios announced in 2011 that it would start financing British independent films and has already invested in a number of exciting projects. The BFI Film Fund is the UK's largest public investor in film - supporting first-class film-making through development and production, to distribution and international sales and investing in the production of around 25-30 feature films per year. The BFI has supported a range and breadth of projects from new and emerging talent to some of the most iconic British independent films ever made including *The King's Speech* and *The Woman in Black*. Pinewood and the BFI have co-invested in four films to date, *Last Passenger, Belle, Our Robot Overlords* and *Posh* with the potential for many more collaborations in the future.

Launching the new scheme on a visit to Pinewood Studios, Maria Miller MP, Secretary of State for Culture, Media and Sport said: "The Government recognises that developing skills and training are essential if the UK is to keep its leading place in world film. I am delighted that Pinewood is supporting our ambitions in this area with this initiative.

The UK's creative industries are of huge economic importance to the UK and are something we should be incredibly proud of. We need to ensure that those who want to work in this industry have access to the right expertise so as they can continue the success story of British film and I congratulate Pinewood on its dedication in developing the next generation of film talent."





Amanda Nevill, CEO of the BFI said: "A major focus of the BFI's forward vision for UK film is about identifying and developing emerging talent and supporting the next generation on who we will depend for a vibrant industry and culture in the future. It's great to be coming together with Pinewood to emphasise this joint commitment."

The BFI shares Pinewood's passion for skills development and we are excited that by joining forces we can leverage our reputations and work with productions to embed this good practice."
